

'Router it & WIN' promotion

Terms & Conditions

1. Promotion overview

- 1.1. The Altus[®] Industrial Aluminium 'Router it & Win' (the "Promotion") is conducted by Altus[®] Industrial Aluminium, a business unit of Altus[®] New Zealand Limited ("the Promoter").
- 1.2. The Promotion applies to Project Orders entered into the Altus[®] Industrial Aluminium Router System during the Promotion Period, with goods dispatched, invoiced, and supplied before 30 September 2025.

2. Eligibility

- 2.1. The Promotion is open to any customers who utilise the Altus[®] Industrial Aluminium Router Service during the Promotion Period in line with these Terms and Conditions.
- 2.2. The Promotion is open to New Zealand-based businesses only.
- 2.3. Employees of the Promoter, their immediate families, and any agencies associated with the Promotion are not eligible to enter.

3. Promotion period

- 3.1. The Promotion starts on Tuesday 1 July 2025 and ends at 5:00pm on Friday 29 August 2025, unless extended or terminated at the Promoter's discretion.
- 3.2. Project Orders submitted outside the Promotion Period will not be eligible for entry.
- 3.3. Only orders that are dispatched, invoiced, and supplied before 30 September 2025 will qualify.

4. How to enter

- 4.1. Eligible customers will receive one automatic entry into the prize draw for each qualifying Project Order entered into the Altus[®] Industrial Aluminium Router System during the Promotion Period.
- 4.2. To qualify, products must be supplied within the eligibility timeframe. Orders will not be held in stock for later dispatch or future use.
